General terms and conditions for Statement/400 Software b.v.

1

- 1.1 The present general terms and conditions apply to all our transactions and agreements.
- 1.2 These general terms and conditions also apply if Statement/400 Software b.v. provides a client with a software package on trial for a period of time.

- 2.1 Statement/400 Software b.v. guarantees that the software supplied shall meet the specifications, contain the features and perform the operations stated in writing.
- 2.2 In the event of any proven defects and/or shortcomings in the software provided that are essential to the software's proper operation, Statement/400 Software b.v. shall endeavor to restore them within a reasonable period following written notification from the client.

3

- 3.1 The client shall pay invoices within 14 days of receipt.
- 3.2 After said term, the client shall owe interest according to the statutory rate on the amount of the invoice. No notice of default or warning shall be necessary.
- 3.3 In no case shall the client be authorized to suspend or offset his payment obligations arising from the agreement.

4

- 4.1 In the event of any damages resulting from the failure or partial failure by Statement/400 Software b.v. to fulfil its legal obligations. Statement/400 Software b.v. shall be liable only if such action is deliberate or reflects gross negligence.
- 4.2 In no case shall the liability for the damages stipulated in 4.1 exceed the agreed purchase price for the software.

5

- 5.1 If a software package supplied by Statement/400 Software b.v. comes with any type of security features against abuse, the client shall respect such security features and leave them intact.
- 5.2 Each time the client violates the obligation stated in 5. 1, he shall forfeit a penalty of NLG 20,000 immediately. This penalty shall not diminish the right of Statement/400 Software b.v. to compensation for damages.

6

- 6.1 All our agreements are subject to Dutch law.
- 6.2 In any dispute concerning the conclusion, interpretation or implementation of this agreement, whether legally or factually, the court in Rotterdam shall have exclusive jurisdiction.
- 6.3 Notwithstanding the provisions in 6.2, the parties may decide among themselves to submit their dispute to a third party charged with giving a binding opinion. Each party shall advance half the fees for this advisor. Ultimately, the party found to be entirely or partially in the wrong shall be responsible for all such fees.
